Official Rules

Any attempt by any Entrant to obtain more than the stated number of Entries by using multiple/different email addresses, identities, registrations, and logins, cheating or fraud, through a sweepstakes club or similar entity, or any other unauthorized methods will void all the Entrant's Entries and Entrant will be disqualified from the Sweepstakes. If Sponsor suspects that any Entrant has or appears to have submitted mass Entries, or Entries generated by an automated program, bot, script, robotic, macro or use of any other devices is prohibited and will result in disqualification. Winner will be responsible for Taxes, License fees, and Documentation Fee. Winner will have to complete the necessary paperwork at See-Grins RV before taking possession of the trailer.
